<b>General Duties</b>	<ul style="list-style-type: none"> <li>• Be aware of and comply with all relevant school policies, including those relating to safeguarding, health and safety and data protection.</li> <li>• Promote inclusion by embodying the ethos, values and aims of the school.</li> <li>• Encourage independence of children through practical assistance, training and by being a positive role model.</li> <li>• Accompany groups who are participating in educational visits.</li> <li>• Prepare classrooms for lessons, as directed by the class teacher.</li> <li>• Support the holistic needs of all children, working closely under the direction of the class teacher.</li> <li>• Provide general administrative and clerical support to the class teacher with regards to lesson planning and resources.</li> <li>• Undertake record keeping as requested.</li> <li>• Demonstrate and promote commitment to equal opportunities.</li> <li>• Liaise with the SENDCO regularly to review the progress of individual children with SEND.</li> <li>• Be responsible for interventions for named children or small groups of children.</li> </ul>

<b>Specific Responsibilities:</b>	<b>Supporting Teachers</b>
	<ul style="list-style-type: none"> <li>● Assist the class teacher with creating and maintaining displays throughout the classroom and other areas of schools as needed.</li> <li>● Undertake activities set by the class teacher with individual, and groups of children to ensure their safety and assist with their physical, emotional and educational development.</li> <li>● Support learning activities and teaching programmes, adjusting activities where needed liaising with the class teacher, according to children's responses.</li> <li>● Contribute to keeping records of children's development and communicating any concerns directly to the class teacher or other member of the leadership team if necessary.</li> <li>● Assist with monitoring the needs of children, including educational progress and emotional support.</li> <li>● Assist with monitoring the progress of children with SEND, referring to their EHC plans and reporting back to the class teacher / SENDCO.</li> <li>● Help to ensure that classrooms are orderly, supportive and engaging.</li> <li>● Assist with implementing a variety of teaching strategies, in liaison with the class teacher to support children to achieve their learning goals.</li> <li>● Provide detailed and regular feedback to the class teacher on children's achievement, progress and developmental needs.</li> <li>● Promote good behaviour, reporting and dealing promptly with conflicts and incidents in line with the school's behaviour policies.</li> <li>● Establish constructive relationships with parents and carers where required.</li> </ul>
	<b>Supporting Children</b>
	<ul style="list-style-type: none"> <li>● Supervise children's work, offering support/resources where necessary, including children with SEND, working both within the classroom and outside.</li> <li>● Contribute to the delivery and evaluation of interventions and small group activities.</li> <li>● Where needed, assist the class teacher with the creation of individual learning plans for specific children.</li> <li>● Assist with supporting specific programmes linked to learning strategies. e.g. Phonics</li> <li>● Encourage and support children to interact with each other and engage positively in their learning.</li> <li>● Provide feedback to children in relation to their progress and achievement under guidance from the class teacher.</li> <li>● Attend to children's personal needs, and implement personalised assistance to help with their social, emotional and educational development.</li> <li>● Assist with health and safety needs including support and care for those suffering from minor injuries. (First Aid training will be provided)</li> <li>● Support children at mealtimes, where necessary.</li> <li>● Contribute appropriately, where necessary, to reviews of behaviour and SEND.</li> <li>● Communicate effectively and sensitively with children to adapt to their needs and support their learning.</li> </ul>
	<b>Supporting the School</b>
	<ul style="list-style-type: none"> <li>● Establish a supportive relationship with the children and their parents/carers (where necessary), acting as a role model and being aware of and responding to individual needs.</li> <li>● Promote inclusion and acceptance of all children, including those with SEND.</li> <li>● Be aware of confidential issues linked to children maintaining strict levels of confidentiality.</li> <li>● Be aware of the school policies and procedures and follow these at all times. e.g Child Protection and Safeguarding, Behaviour, SEND, Data Protection, Health and Safety.</li> <li>● Participate in professional development and training to enable the very best support for the children.</li> </ul>

	<b>Professional Development</b>
	<ul style="list-style-type: none"> <li>• Participate in training and other professional development as required.</li> <li>• Provide the school with feedback on any training or professional development undertaken.</li> <li>• Report professional development progress to an assigned line manager and set goals for further professional development through the school's performance management processes.</li> </ul>
